

**AMENDMENT TWO
TO THE
CONTRACT FOR ACCESS AND VISITATION GRANT BETWEEN
THE OFFICE OF THE ATTORNEY GENERAL
AND
TARRANT COUNTY**

OAG Contract Number: 21-C0005

This Amendment Two to the Contract for Access and Visitation Grant (“Amendment Two”) is entered by and between the Office of the Attorney General (the “OAG”) and Tarrant County (the “Subrecipient”). The OAG and the Subrecipient may be referred to in this Amendment Two individually as (a “Party”) and collectively as (the “Parties”). The Parties to the Contract for Access and Visitation Grant, dated effective December 1, 2020 (the “Contract”), now desire to amend the terms of the Contract and agree as follows:

1. Section 2, TERM. The OAG elects to exercise the second of three (3) optional one (1) year renewal terms of the Contract, for Federal Fiscal Year (FFY) 2023. The first renewal term commenced on October 1, 2021 and will expire on September 30, 2022. The second renewal term will commence on October 1, 2022 and will expire on September 30, 2023.
2. Section 5.1, Maximum Liability. The maximum liability under the Contract increases to One Hundred Eighty-Six Thousand Six Hundred Six and 90/100 Dollars (\$186,606.90). The Parties agree that the maximum liability for the renewal term, FFY 2023, is Sixty-Two Thousand Two Hundred Two and 30/100 Dollars (\$62,202.30).
3. Section 5.2, Contract Budget. The Contract amount will be allocated by FFY, subject to renewal and approval at the end of each FFY in accordance with Section 2. The budget categories and amounts for the second renewal term of this Contract are provided in Section 5.2.2 below, and in Attachment C: Access and Visitation Detailed Program Budget Report.
4. Amend Contract Section 5.2.2, State Fiscal Year Annual Budget to a Federal Fiscal Year Annual Budget.
5. Section 5.2.2, Federal Fiscal Year 2023 Annual Budget is amended per the chart below and as further detailed in the Access and Visitation Detailed Program Budget Report (Attachment C).
