RE: Auditor's Report – Sheriff's Bond Desk System Upgrade


We initiated a review to determine whether financial and system controls were adequate to reasonably ensure bond transactions were properly accounted for and safeguarded from theft. The *Tech.Share Bond Desk* went live on January 12, 2022. The system replaced the legacy bond management system used to record cash bonds, fines, and escrow payments received from bondsmen. After the initial cutover, we observed that collateral reports did not reconcile between the two systems because of a data conversion error. We also observed that two users had the ability to edit collateral, receipt bonds, and void their own transactions. Subsequent to our review, the collateral reports reconciled between systems and the two users' roles and permissions were modified. Because certain control procedures or reports are not in place, a *significant risk* exists errors or fraud could go undetected. Specifically, we observed:

- 1) Supervisory review of voided bonds, particularly cash bonds, did not exist.
- 2) A comprehensive report showing voids and adjustments made by staff was not available.

We recommend the Sheriff's Office develop procedures that includes an independent supervisory review of voids and adjustments. This review should be documented. Furthermore, we recommend the Sheriff's Office work with the Information Technology Department and the vendor to provide a comprehensive report showing voids and adjustments.


