

**STATE OF TEXAS           §           Renewal and Amendment of Funding Interlocal Agreement**  
**§           for Ragland Road Reconstruction and Widening**  
**COUNTY OF TARRANT §           (Construction Phase)**

**BACKGROUND**

1. Tarrant County (“COUNTY”) and the City of Grand Prairie (“CITY”) entered into a Funding Interlocal Agreement (ILA) approved on May 5, 2020 by Commissioners Court Order No. 132753 for the financial support of up to \$1,501,643.00 through the Tarrant County 2006 Transportation Bond Program (TBP) for the construction phase of the Ragland Road Reconstruction and Widening (“Project”) from State Highway 360 (SH 360) to the Loyd Park entrance.
2. The COUNTY and the CITY desire to renew and amend this Funding ILA to clarify the scope for the Project and to facilitate the reimbursement of TBP funding to the CITY.

Therefore, the COUNTY and the CITY agree to the following:

3. Section I (Project Description) is amended to read as follows:  
  
The project will include the reconstruction of Ragland Road from SH 360 to the Loyd Park entrance from an existing two-lane asphalt roadway to a concrete roadway with drainage and utility improvements. The section of Ragland Road between SH 360 and Day Miar Road will also be widened to accommodate the restriping of the roadway to five lanes in the future. The project also reconstructs and widens a 500-foot section of Day Miar Road south of Ragland Road from a two-lane asphalt roadway to a concrete three-lane roadway with curb and gutter.
4. Section III (Term) is amended to read as follows:  
  
This ILA will expire on September 30, 2023.
5. The COUNTY and the CITY agree to the revised Payment Schedule in Attachment A.
6. Except as amended above, this Funding ILA remains in full force and effect.
