Page 15, Exhibit "C", LEASE TERM

The Commencement Date of the Lease shall be January 1, 2023. The term of the Lease shall begin on the Commencement Date and shall continue for a period of One (1) Year, ending December 31, 2023, as provided in Article II(B) of the Lease.

Both parties are in agreement as to the above. All other provisions of the above mentioned Lease Agreement remain in full force and effect. This Amendment is effective upon execution of this addendum.
