Good afternoon Alice,

In addition to Wagley Robertson, N. Old Decatur (north of Bailey Boswell to the city limits near Fellowship Baptist Church) is scheduled to be reconstructed with an additional lane. We have a funding gap of approximately \$300,000 if this is something the Commissioner might consider for discretionary funds. It is almost designed and we could get it to bid for construction quickly.

Part of the timeliness related to this project is that it will include sidewalks. Kids in the vicinity are walking along the street to go to nearby Wayside Middle School, which does not present a safe condition and needs to be corrected.

**This project consists of roadway widening, internal storm drain and major culvert crossing, water line relocations, sanitary sewer adjustments, illumination, pavement markings and signage, traffic signal modifications, and traffic control for approximately 1,500 linear feet of 3-lane undivided concrete section along Old Decatur Road from Bailey Boswell Road to the Saginaw City Limits.**

**Old Decatur Road from Bailey Boswell Road to the Saginaw City Limits**
