COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court conduct a public hearing on Tuesday, January 10, 2023 at 10:00 a.m., to consider the placement of stop signs in the right-of-way of Santa Fe Trail East and Santa Fe Trail West to serve the intersection of Santa Fe Trail West and Remington road and the paved connector between Santa Fe Trail East and Santa Fe Trail West, Precinct 2.

BACKGROUND

At the request of Precinct 2 staff, the County engineer evaluated the triangular intersection of Remington Road, Santa Fe Trail East, and Santa Fe Trail West for the installation of stop signs. After a site visit and review, the county engineer recommends the installation of three (3) stop signs as identified below:

- Installation of a stop sign on Santa Fe Trail West at the intersection of Remington Road.
- Installation of a stop sign in the Santa Fe West right-of-way serving the paved connector from Santa Fe East.
- Installation of a stop sign in the Santa Fe East right-of-way serving the paved connector from Santa Fe West.
