SUBJECT: APPROVAL OF FIRST AMENDMENT TO THE SUBRECIPIENT AGREEMENT BETWEEN TARRANT COUNTY AND UT SOUTHWESTERN MONCRIEF CANCER CENTER, D/B/A MONCRIEF CANCER INSTITUTE FOR MOBILE PREVENTATIVE CANCER SCREENINGS AS PART OF THE TARRANT COUNTY FISCAL RECOVERY FUNDS PROGRAM

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve the First Amendment to the Subrecipient Agreement with UT Southwestern Moncrief Cancer Center, d/b/a Moncrief Cancer Institute for mobile preventative cancer screenings as part of the Tarrant County Fiscal Recovery Funds program.

BACKGROUND

On January 18, 2022, the Commissioners Court, through Court Order #137259, approved a Subrecipient Agreement between Tarrant County and UT Southwestern Moncrief Cancer Center, d/b/a Moncrief Cancer Institute in the amount of \$9 million as part of the Tarrant County Fiscal Recovery Funds program.

Through this program, Moncrief Cancer Institute provides mobile cancer screenings and diagnostic services to unscreened patients, including historically unserved or underserved communities or individuals who delayed or have not completed a scheduled screening since the onset of the COVID-19 pandemic.

As a result of this action, funds within the original budget will be reallocated to support increased outreach efforts and to purchase a smaller mobile unit to allow greater flexibility in serving target populations. This amendment does not increase the overall award amount to UT Southwestern Moncrief Cancer Center, d/b/a Moncrief Cancer Institute.

There is no fiscal impact associated with this item.

**FIRST AMENDMENT TO THE SUBRECIPIENT AGREEMENT BETWEEN

Tarrant County ("COUNTY") and UT Southwestern Moncrief Cancer Center d/b/a Moncrief Cancer Institute ("SUBRECIPIENT"), each a "Party" and collectively the "Parties" to a Subrecipient Agreement related to the use of State and Local Fiscal Recovery Funds ("FRF") dated January 12, 2022 (the "Agreement"), now wish to amend the Agreement. This amendment is effective upon the signature of the Parties.

WHEREAS, on January 18, 2022, through Court Order No. 137259, COUNTY approved an agreement with SUBRECIPIENT; and

WHEREAS, COUNTY wishes to amend that agreement to reallocate funds to support increased outreach efforts and the purchase of a second, smaller mobile unit to increase SUBRECIPIENT's ability to reach target populations; and

WHEREAS, COUNTY and SUBRECIPIENT wish to amend that agreement to include key performance indicators to track the success of SUBRECIPIENT's increased outreach efforts.


NOW, THEREFORE, the Parties agree as follows:




