SUBJECT: **BID NO. 2023-018 - PURCHASE OF 4,000 GALLON WATER TANK TRUCK - PRECINCT 2 - PREMIER TRUCK GROUP - \$217,565.00**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid 2023-018, Purchase of 4,000 Gallon Water Tank Truck, for Precinct 2, to Premier Truck Group for \$217,565.00.

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred twenty-one (121) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on October 26, 2022 was attended by three (3) vendors as well as representatives from Precincts 1, 2, 4, and Purchasing. One (1) bid and one (1) no-bid were received.

The low bid received from Premier Truck Group meets all specifications and is acceptable to Precinct 2.

Therefore, it is the joint recommendation of Precinct 2 and Purchasing that Bid No. 2023-018, Purchase of 4,000 Gallon Water Tank Truck, be awarded to Premier Truck Group for \$217,565.00.
