This Addendum is made and entered between Wrightson Johnson Haddon Williams ("WJHW") and Tarrant County ("COUNTY"), collectively known as "parties", pursuant to the terms and conditions of the Master Agreement, dated January 17, 2023 ("Agreement"). The terms and conditions contained in the agreement shall govern the relationship of the parties described herein.

Term of SOW	 This Addendum shall be effective from the date it is executed by both parties through the completion of the scope of work. The anticipated completion of work is on or before June 2024 Design – 8 weeks Bid & Negotiation, Installation and Closeout – TBD
Project Understanding	 We understand the project to include renovations to the Commissioners Court, Control Room, Meeting Room 504C and Family Law Assembly Room Audio Visual (AV) and Video Production (VP) systems. WJHW to also provide recommendations on required specialty lighting systems, acoustic treatment, structured cabling, architectural and electrical work to support the AV and Video Production systems.
Overview/Context of Services	 AV and Video Production Systems design and development of construction documents for bidding. Bid review and construction administration services.
Services	Based on preliminary review meetings and initial COUNTY input, WJHW will provide the following design services for the Commissioners Court, Meeting Room 504C and Family Law Assembly Room. These services are subject to change through Design Development based on additional review and user input. Reference attached Commissioners Court Assessment and Programming document for additional information on initial design considerations. 1. AV systems at Commissioners Court including: • A centralized AV over IP solution for video transport using a combination of encoders and decoders. • A variety of system inputs including HDMI, wireless presentation system, COUNTY provided PC, video feeds from the broadcast system and a video feed from the voting system. • Large and medium format displays located throughout the courtroom to ensure visibility of displays throughout the space. • Touch display at each dais seat and lectern for content viewing, AV control and voting. • Combination of tabletop wired gooseneck microphones, handheld and lapel wireless microphones and ceiling mounted microphone arrays to allow voice lift as required. • Speakers in the rear of the courtroom for sound reinforcement in general areas and small format speakers at the dais and auxiliary seats. • Line level audio outputs at multiple locations around the courtroom to act as Press Feeds • If needed, audio recorder with the capability to automatically save recorded files to a COUNTY

- specified network location.
- An Assisted Hearing System to comply with ADA guidelines.
- Court Reporter connections.
- Voting system that will fully integrate into the control system and touch panels and that will have the ability to manage the agenda and provide a record of all votes.
- A control system with the ability to fully control all AV functions of the Courtroom, have full remote monitoring and troubleshooting capabilities and provide basic lighting control via predetermined presets.
- WJHW to consult and collaborate with the County agenda management software vendor to optimize connectivity and integration with the new system.
- 2. AV systems at Meeting Room 504C including:
 - Ability to view video sources and cameras from the Court.
 - A variety of system inputs including HDMI, wireless presentation system and COUNTY provided PC.
 - Video inputs distributed using the centralized AV over IP system as part of the Commissioners Court.
 - Large format wall mounted display for viewing of video sources
 - Video conferencing capabilities including PTZ camera, speakers, and microphone arrays.
 - Touch panels to control all AV system functions within the room.
- 3. AV systems at Family Law Assembly Room including:
 - An AV over IP system for video transport within the room.
 - A variety of system inputs including HDMI, wireless presentation system and COUNTY provided PC.
 - Video projectors and motorized projection screens with the capability of sending a separate video input to each projector.
 - Multiple microphone connections located on wall plates and floor boxes, a tabletop goose neck
 microphone at the lectern, an array of wireless microphones and handheld and lapel wireless
 microphones.
 - Loudspeakers to properly cover the room and a separate dedicated set of speakers arranged to provide a mix minus setup to help reduce the chance of feedback.
 - Multiple touch panels to provide control capabilities of the AV system.
- 4. Video Production systems at Commissioners Court including:
 - A complete video production system for the County Commissioners Court and auxiliary spaces (Meeting Room 504C and Family Law Assembly Room) to support live video delivery to the County's online content management systems as well as producing archive video of meetings and events within these spaces.
 - A video control room/equipment rack room to house the primary video production technology and operational positions.
 - A portable fly pack that can be quickly deployed in the event of a catastrophic systems failure or the need by the County to broadcast from outside of the primary control room.
 - Full production coverage in the Commissioners Court, Commissioners Court Meeting Room, and Family Law Assembly Room (system will be able to produce content from any of these spaces, but it will only facilitate one production at a time).
 - Video production system based around HD video technology.
 - Multiple remote operated PTZ cameras installed throughout the Commissioners Court connected to the primary video production router.
 - A dedicated meeting control system to allow single operator productions, acting as a bridge between the individual system components allowing one operator to control an entire system from (2) dedicated touch screen displays.
 - Multiple IP encoders to transmit the HD signal to the County's broadcast content delivery network (CDN), currently YouTube.
 - New equipment racks, power distribution and broadcast millwork to support the system.
 - The video production to interface with the audio-visual system to allow all audio and video sources in the space to be viewable in the room.
 - Telepresence in the system to allow remote video & stake holder participants as well as a remote court reporter.
