

Public notice must be issued at least 48 hours prior to the spray mission. Describe how the advanced notice will be given to the affected public before an operation: Ideally, advance notice for aerial spraying would range from 7-14 days prior to action, with reminders 1-3 days leading up to the action in the designated sprayed area.

Describe the timeline and/or frequency public notice is posted. (e.g. once a year on the first of May and every 30 days thereafter) West Nile activities begin in late April, with a training session. Not far behind is the updating of awareness and prevention information on the website. That is followed by distribution to the media for local residents. Ongoing communications continue throughout the season.
