FIRST AMENDMENT TO DEPOSITORY CONTRACT FOR CERTAIN TRUST FUNDS AND COURT REGISTRY FUNDS HELD BY THE COUNTY CLERK

THIS FIRST AMENDMENT TO DEPOSITORY CONTRACT FOR CERTAIN TRUST FUNDS AND COURT REGISTRY FUNDS HELD BY THE COUNTY CLERK (this "Amendment"), is effective as of April 18, 2023 (the "Effective Date"), and is entered into by and between JPMORGAN CHASE BANK, N.A., a national banking association (the "Bank") and TARRANT COUNTY (the "Depositor").

RECITALS

WHEREAS, the Depositor and the Bank are parties to the Depository Contract for Certain Trust Funds and Court Registry Funds Held by the County Clerk with a term that commenced June 25, 2019 (including any documents incorporated by reference therein, and as amended or extended from time to time, the "Agreement"); and

WHEREAS, the Depositor and the Bank desire to extend the term of the Agreement an additional two years, as allowed by TEX. LOC. GOV'T CODE ANN., §116.021, and to modify certain provisions of the Agreement, subject to the terms of this Amendment.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants and agreements contained herein, Depositor and Bank hereby agree as follows:

- 1. The Depositor and Bank mutually agree to renew and extend the Agreement an additional two years, with such extension term to begin June 11, 2023, and continue thereafter in full force and effect through June 7, 2025, unless sooner terminated as provided in the Agreement.
- 2. The Depositor and Bank agree to modify Section II. A. of the Agreement by adding the following: "Notwithstanding anything to the contrary in the Agreement, the option to reset at each account's annual anniversary date will terminate on December 31, 2023. After December 31, 2023, upon the request by the County Clerk, the County Clerk will have the option at each account's *maturity date* to reset the rate at the then prevailing two-year stated Certificate of Deposit rate plus 15 basis points."
- 3. Bank and the Depositor hereby ratify and reaffirm the terms and conditions of the Agreement, and that the Agreement shall remain in full force and effect, as modified by this Amendment.
- 4. Bank and the Depositor hereby incorporate this Amendment into the Agreement.
