Condition of Loans by Tarrant County Office of Historic Preservation and Archives

CARE AND PRESERVATION

1. Loss or damage, whether in transit or on the borrower's premises, and regardless of who may be responsible, must be reported immediately. Photographs and documents of damage (e.g. condition reports) with dates, names, and other details of the occurrence must be sent to the Tarrant County Office of Historic Preservation and Archives within 5 working days of the loss or damage.
2. Item is loaned with the understanding that it will be returned in the same condition. Borrowing institution will be held responsible for damage or loss of item.
3. Objects must be given special care to protect them against loss, breakage, or deterioration. Small objects must be displayed in locked cases. Large objects and artwork not displayed in cases or behind glass must have sufficient distance from the public to avoid touching. Exhibit areas must be under surveillance by guards or other staff when open to the public.
4. Objects must be protected against light damage by the use of (1) ultra-violet filters on fluorescent and incandescent lights or (2) ultra-violet filtering Plexiglas in frames or cases. Cases must be designed so that the lighting element (or at least the ballast) is outside the enclosed area. Temperature should be 68-72°F and 50% RH \pm 5%.

TRANSPORTATION AND PACKING

1. The method of shipment must be agreed upon by both parties.
2. The Lender will assure the loan items are adequately and securely packed for the type of shipment agreed upon, including any special instructions for unpacking or repacking. Items will be returned packed in the same or similar materials as received unless otherwise authorized by the Lender.

ACCESS

1. Access to loaned objects by individuals for purposes other than those identified on the attached agreement must receive prior approval by the Lender and must be supervised by the Borrowers. Use of the loaned material must be restricted to a supervised area. Researchers will be subject to the Lender's current user rules and restrictions. Borrower will be responsible for any misconduct by persons "using" materials.

RETURN OF LOAN

1. Any extensions of the loan period must be requested by the Borrower. The Lender will prepare extension documents to be completed and signed by the Borrower and received by the Lender at least 30 calendar days prior to the original loan expiration date shown on the attached agreement. All additional insurance will be extended by the Borrower and proof of insurance will be provided to the Lender by a copy of the certificate of insurance.
2. The Lender reserves the right to inspect or audit the objects on loan at any time. Should the Lender desire to recall any of the loan material for its own purposes, it may do so by giving at least 30 days notice to the Borrower. Loaned objects may be withdrawn by the Lender without written notice to the Borrower if it is determined that they are receiving improper care.

This agreement shall be construed in accordance with the laws of the State of Texas.
