**FIRST AMENDMENT TO  
INTERLOCAL AGREEMENT**

**COUNTY OF TARRANT**

WHEREAS on May 2, 2023, the Commission's Court approved through Court Order No. 140843, Tarrant County, Texas ("COUNTY") and the City of Colleyville ("CITY") entered into an Interlocal Agreement ("ILA") for the COUNTY's assistance to:

- Rehabilitate and Resurface **Bluebonnet Drive** located within the City of Colleyville from West Glade Road to Riverwalk Drive (Approximately 2,550 linear feet).
- Rehabilitate and Resurface **North Timberline Drive** located within the City of Colleyville from Bransford Road to South Timberline Drive (Approximately 3,154 linear feet).
- Rehabilitate and Resurface **South Timberline Drive** located within the City of Colleyville from Bransford Road to North Timberline Drive (Approximately 2,682 linear feet).

Collectively, hereinafter referred to as the "**Project**".

NOW, THEREFORE, the COUNTY and the CITY desire to amend the Agreement to add the following additional PROJECT location:

- Resurface **Tinker Road** located within the City of Colleyville from Pleasant Run Road to 70 ft east of Kingston Drive (Approximately 3,425 linear feet).
- Resurface **Roberts Road** located within the City of Colleyville from Glade Road to 175 ft South of Fox Meadows Drive (Approximately 1,396 linear feet).

AND, WHEREAS, the COUNTY's Responsibilities will be amended to include:

- **Tinker Road:** The CITY will wedge mill and remove excess materials. The COUNTY will tack the prepared roadway, place two inches of asphalt surface, and clean the project jobsite.
- **Roberts Road:** The CITY will mill and remove excess materials. The COUNTY will tack the prepared roadway, place two inches of asphalt surface, and clean the project jobsite.

All other conditions and requirements of the ILA remain the same.
