

Amendment 1 to the  
GovOS REMOTE MARRIAGE APPLICATION SUBSCRIPTION AGREEMENT

This Amendment is made and entered into by and between GovOS, INC. ("GovOS"), and Tarrant County, ("Customer"), collectively known as "parties", pursuant to the terms and conditions of the GovOS REMOTE MARRIAGE APPLICATION SUBSCRIPTION AGREEMENT, dated, July 5, 2022 ("Agreement"). The terms and conditions contained in the Agreement shall govern the relationship of the parties as described herein.

The Amendment modifies the Agreement to remove section "4. Payment Terms a. Fees":


**4. Payment Terms a. Fees.** Fees for the Initial Term are \$113,000.00 Payment of fees for the Initial Term will be invoiced and adhere to three (3) milestones during the initial year: contract execution, limited release, and full release to AWS Government cloud infrastructure. Customer will be invoiced 40% (\$45,200.00) upon contract execution, then invoiced 40% (\$45,200.00) upon limited release to vendor's existing AWS Cloud infrastructure, and a final invoice of 20% (\$22,600.00) upon full release to AWS Government Cloud infrastructure. Vendor **must** complete the full deployment to AWS Government Cloud by March 31, 2023 or Customer will have the option of terminating with five (5) days written notice or continuing to utilize the Services during the Initial Term without payment of the final milestone payment until deployment to AWS Government Cloud is complete. Payment for fees for any Renewal Terms will be invoiced at the beginning of each Renewal Term.

The Amendment subsequently modifies the Agreement to insert a new section "4. Payment Terms a. Fees":

**4. Payment Terms a. Fees.** Fees for the Initial Term are \$113,000.00. Payment of fees for the Initial Term will be invoiced and adhere to three (3) milestones during the initial year: contract execution, limited release, and full release based on Customer validation of hosting. Customer will be invoiced 40% (\$45,200.00) upon contract execution, then invoiced 40% (\$45,200.00) upon limited release to vendor's existing AWS Cloud infrastructure, and a final invoice of 20% (\$22,600.00) upon GovOS enabling remaining Customer required data entry fields, as detailed in Appendix A, and Customer validating in writing that the required data entry fields are available and functioning correctly. Payment for fees for any Renewal Terms will be invoiced at the beginning of each Renewal Term.

This Amendment is effective as of the date of signature of the last party to sign as indicated below.
