

**FIRST AMENDMENT TO THE SUBRECIPIENT AGREEMENT BETWEEN
TARRANT COUNTY AND
BOYS & GIRLS CLUBS OF GREATER TARRANT COUNTY**

Tarrant County (“COUNTY”) and Boys & Girls Clubs of Greater Tarrant County (“SUBRECIPIENT”), each a “Party” and collectively the “Parties” to a Subrecipient Agreement (“Agreement”) related to the use of State and Local Fiscal Recovery Funds (“FRF Funds”), now wish to amend the Agreement. This amendment is effective upon the signature of the Parties:

WHEREAS, on September 27, 2022, through Court Order No. 139220, COUNTY approved an agreement with SUBRECIPIENT; and

WHEREAS, COUNTY wishes to amend that agreement to reallocate funds from travel, supplies, and other expenditures to personnel and fringe to improve SUBRECIPIENT’s ability to administer the Mobile Clubhouse Experience program throughout Tarrant County.

NOW, THEREFORE, the Parties agree as follows:

1. Appendix A shall be modified as included herein.
2. Except as modified by this Amendment, all terms and conditions of the Agreement shall remain in effect.
