SUBJECT: APPROVAL OF LETTER OF CONCURRENCE REGARDING FOREIGN TRADE ZONE DESIGNATION FOR ALLIED ELECTRONICS, INC.

COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court approve the Letter of Concurrence to the Foreign Trade Zones Board allowing for the Foreign Trade Zone (FTZ) designation for Allied Electronics, Inc. for its facility location at 7151 Jack Newell Blvd. South in Fort Worth.

BACKGROUND:

Allied Electronics, Inc. is a distributor of industrial automation products, electronic componenets and electromechanical products with sales offices in North and South America. Their Fort Worth operations include a 357,000 square foot distribution center located at 7151 Jack Newell Blvd. South, that currently employs approximately 500 people.

Allied Electronics plans to expand their Fort Worth facility by adding 207,000 square feet of office and warehouse space and adding 200 or more employees within the next two (2) years. Allied Electronics is seeking a FTZ site designation within FTZ Number 39. The FTZ designation will assist Allied Electronics by providing a better and more efficient supply chain flow, and allow cost savings from the exempted or deffered duties. Allied Electronics' facility currently receives a partial exemption of inventory tax through the Freeport Exemption. With the addition of a FTZ designation, additional inventory value will be exempted. However, tax revenues from the added real property tax value due to the facility expansion are expected to offset the reduction in inventory taxes.

Allied Electronics, Inc. is requesting Tarrant County's approval of a "no objection" letter concurring with their application for FTZ designation. The City of Fort Worth and Birdville ISD have approved a similar Letter of Concurrence.

FISCAL IMPACT:

Allied Electronics has current inventory at the site valued at approximately \$133,000,000, of which 81.5% is being exempted under Freeport Exemption. The inventory value is expected to increase by approximately \$39,000,000.00 with the facility expansion. However, the FTZ designation would exempt 75% of the remaining inventory after Freeport exemption, leaving just \$7,955,000.00 in projected taxable value. The planned facility expansion is expected to add \$30,000,000.00 in taxable

real and business personal property value to the site. The added tax revenue from the new facility value is expected to offset any reduction in taxes from additional FTZ inventory exemption.

Current County tax revenue at the site is approximately \$86,592.00. With the facility expansion and FTZ designation, County tax revenues are estimated at \$173,675.00. For the Hospital District, current tax revenues are estimated at \$83,050.00. With the facility expansion and FTZ designation, Hospital District tax revenues are estimated to be \$166,571.00.



PROJECT OVERVIEW:

Allied, is requesting that 42 acres located at 7151 Jack Newell Blvd. South, in Fort Worth, Texas 76118-7037 within Tarrant County, be designated as a Zone Site within Foreign-Trade Zone No. 39. Foreign-Trade Zone No. 39 is overseen by the Dallas/Fort Worth International Airport Board (DFW Airport Board) and as the Grantee, the DFW Airport Board is sponsoring this application request to the Department of Commerce's FTZ Board in Washington D.C.

Following is a Google map, which provides a quick view of where their operation is located in proximity to the surrounding area.



The distribution facility located at 7151 Jack Newell Boulevard South currently consists of one building totaling 357,000 square feet of office and warehousing space. Allied plans on expanding their facility and adding 207,000 square feet more of warehousing space at this operation. Allied will be utilizing this space to distribute consumer goods directly to their domestic and international customers.

Following is an aerial picture of the current site and building with an overlay to reflect where the expansion is to occur.



FTZ status exempts inventory tax on imported goods, and those held for export. As an FTZ, Allied would be provided with tax benefits similar to the Freeport Exemption. Any imported goods that are re-exported will be duty free. Those goods that are held in the FTZ warehouse will be duty deferred until they enter into U.S. Commerce. Because Texas has ad valorem taxes, it is required that all taxing jurisdictions are made aware of the federal exemption on inventory and that the company applying for FTZ designation obtain a letter of concurrence from each such entity.

Allied is seeking to grow and expand in Fort Worth, which will add UP TO 200new jobs at the facility within the next two years, new investment in building and personal property which will directly and positively impact the tax revenue of each entity with which Allied is seeking concurrence for the FTZ. The chart below reflects the current Allied operation and the operation after the expansion occurs. Based on demand in their industry sector and the impact of the current trade environment, the FTZ will assist Allied by providing an increase in supply chain velocity and cost-saving advantages from ability to defer duty.
