ALEC brings together stakeholders to exchange ideas and develop state-based solutions to encourage growth, preserve economic security, and protect taxpayers. The attendee will network with public policymakers to share perspectives to ensure economic security and opportunity in Tarrant County.

B. National Minority AIDS Council (NMAC) – Ending Stigma through Collaboration and Lifting All to Empowerment (ESCALATE) Training, August 13-18, 2023, Detroit, Michigan, for Jonathan Ford, \$0.00*

This three-component program is provided to mitigate and eliminate sigma in HIV-Related service provision in the U.S. The attendee will be trained by experts to recognize and address HIV stigma within every level of Ryan White HIV AIDS Program.

National Alliance of State and Territorial AIDS Directors (NASTAD) Ending the HIV Epidemic Mentorship Meeting, August 14-16, 2023, Philadelphia, Pennsylvania, for Hope Adams, \$0.00*

The attendee will be provided a mentor to help create a work plan to improve the Ending the HIV Epidemic (EHE) program intervention planning, implementation, and evaluation. The plan created will enhance the management of the EHE program within Tarrant County.
