BACKGROUND

1. Tarrant County (“COUNTY”) and the Town of Westover Hills (“TOWN”) entered into a Funding Interlocal Agreement (ILA) on October 19, 2021 by Commissioners Court Order No. 136660 for the financial support of up to \$395,000.00 through the Tarrant County 2006 Transportation Bond Program (TBP) for the construction phase of the Roaring Springs Road Reconstruction (“Project”) within the TOWN limits.

2. The COUNTY and the TOWN desire to renew this ILA to continue funding for the Project.

Therefore, the COUNTY and the TOWN agree to the following:

3. Section III (Term) is amended to read as follows:

This ILA shall terminate on September 30, 2024 unless extended in writing and approved by both parties.

4. The COUNTY and the TOWN agree to the revised Payment Schedule in Attachment A.

5. Except as amended above, this ILA remains in full force and effect.
