DONATION SPECIAL WARRANTY DEED

That TARRANT COUNTY, TEXAS ("Donor"), whose mailing address is 100 E. Weatherford Street, Fort Worth, Texas 76196, have this day Donated and by these presents do Grant, Give and Convey unto the City of Arlington, Texas ("Donee") all that certain tract or parcel of land in Tarrant County, Texas, more particularly described as Exhibit "A", which is attach hereto and incorporated herein for any and all purposes.

SAVE and EXCEPT, HOWEVER, it is expressly understood and agreed that Grantors are making this donation subject to the following term and condition:

- (1) Donee represents and warrants that the land donated will be used for public purposes. If the land ceases to be used for a public purpose, title to and right of possession of the land reverts to Donor immediately.

By acceptance of this donation, the City of Arlington, Texas agrees to the terms and restrictions of the grant and understands that the City's breach of the term and condition will result in the automatic reversion of the donated property to Tarrant County.

TO HAVE AND HOLD the Property, together with all and singular the rights and appurtenances thereto in anywise belonging unto the City of Arlington, Texas and its assigns forever; and Grantors do hereby bind ourselves, our heirs, executors, administrators, successors and assigns to Warrant and Forever Defend all and singular the said premises herein conveyed unto the City of Arlington, Texas and its assigns against every person whosoever lawfully claiming or to claim the same or any part thereof, by, through and under the Grantors, but not otherwise.

DESCRIPTION OF PROPERTY

SITUATED in the City of Arlington, Tarrant County, Texas, and being a part of the Robert R. Ramey Survey, Abstract No. 1341, and a remaining portion of that certain tract conveyed to Tarrant County by deed recorded in Volume 1339, Page 200, Tarrant County Deed Records, and said portion being more fully described as follows:

BEGINNING at a ½" iron rod with an aluminum cap stamped "TARRANT COUNTY" set for an angle point in the south line of the Union Pacific Railroad right-of-way (originally the Texas & Pacific Railroad right-of-way recorded in Volume B, Page 62, said Deed Records) 75 feet south of the centerline of the north track for the northeast corner of said remaining Tarrant County tract, said point by description being in the east line of said R. Ramey Survey;

THENCE South 0 degrees, 17 minutes, 53 seconds East with a west line of said railroad right-of-way and the east line of said remaining portion of Tarrant County tract, at 25.37 feet passing an angle point in the south line of said railroad right-of-way and the northwest corner of that certain tract conveyed to the City of Arlington by deed recorded in Volume 13020, Page 11, said Deed Records, continuing with the west line of said City of Arlington tract (called to be the west line of the M. Brinson Survey, Abstract No. 153) for the east line of the remaining portion of Tarrant County tract, in all 101.54 feet to a ½" iron rod with an aluminum cap stamped "TARRANT COUNTY" set for the southeast corner of said remaining portion of Tarrant County Tract, said point being on a curve whose center bears North 10 degrees, 09 minutes, 49 seconds West, 3039.50 feet;

THENCE westerly with said curve 100 feet south of and concentric with the south line of said railroad right-of-way, and the south line of said remaining portion of Tarrant County Tract, a distance of 506.03 feet to a "MAG" nail set in the asphalt pavement of Forest Edge Drive for the end of said curve;

THENCE South 89 degrees, 22 minutes, 31 seconds West continuing 100 feet south of and parallel to the south line of said Railroad right-of-way and the south line of said remaining portion of Tarrant County tract, 109.87 feet to a point in the east line of Lot 24, Block 1R, Shady Valley North Addition, as shown on plat thereof recorded in Volume 388-117, Page 98, Tarrant County Plat Records;

THENCE North 0 degrees, 34 minutes, 34 seconds West with the east line of said Lot 24, across said remaining portion of Tarrant County Tract, 1.31 feet to the northeast corner of Lot 24;

THENCE South 89 degrees, 47 minutes, 05 seconds West with the most northerly north line of said Shady Valley North Addition, across said remaining portion of Tarrant County Tract, at 1.95 feet passing a ½" iron rod found in place, continuing with the north line of Shady Valley North Addition, passing a ½" iron rod found in place for the common north corner of Lots 23 and 24, said Block 1R, at 396.19 feet passing a "JS COLE 5411" capped ½" iron rod found in place for the common north corner of Lot 21 and 22, said Block 1R, and continuing in all 406.77 feet to the most northerly northwest corner of said Shady Valley North Addition;

THENCE South 37 degrees, 14 minutes, 26 seconds West with a westerly line of said Shady Valley North Addition, 5.34 feet a ½" iron rod with an aluminum cap stamped "TARRANT COUNTY" set in the south line of said remaining portion of Tarrant County tract and the north line of that certain tract conveyed to Agnes Anna Dickinson Estate recorded in Volume 1453, Page 168, said Deed Records;

THENCE South 89 degrees, 22 minutes, 31 seconds West, 100 feet south of and parallel with the south line of said railroad right-of-way for the south line of said remaining portion of Tarrant County tract and the north line of said Dickinson tract, 55.75 feet to a point in the center of Rush Creek for the southwest corner of the remaining portion of Tarrant County tract and the southeast corner of that certain tract conveyed to J. Clyde Jones by deed recorded in Volume 3277, Page 132, said Deed Records;

THENCE North 31 degrees, 39 minutes, 49 seconds East with the centerline of said Rush Creek for the common line of said remaining portion of Tarrant County tract and said Jones tract, 118.27 feet to the south right-of-way line of said railroad (a 150 foot right-of-way at this point per Texas & Pacific Railroad Right of Way and Strip Map dated January 15, 1937);

THENCE North 89 degrees, 22 minutes, 31 seconds East with the south line of said railroad right-of-way for the north line of said remaining portion of Tarrant County tract, at 45.00 feet passing a ½" iron rod with aluminum cap stamped "TARRANT COUNTY" set for reference, and continuing in all 512.48 feet to a ½" iron rod with aluminum cap stamped "TARRANT COUNTY" set for the beginning of a curve whose center bears North 0 degrees, 37 minutes, 29 seconds West, 2939.51 feet;

THENCE easterly with said curve and the south line of said railroad right-of-way for the north line of said remaining portion of Tarrant County tract a distance of 506.78 feet to the PLACE OF BEGINNING and containing a surface area of 2.3859 acres(103,928 Square feet).






of Arlington, Tarrant County, Texas,


