Chaparral Road, Ste. 100, Scottsdale, AZ 85250 successor in interest to Glynlyon, Inc., ("Licensor") and the **Juvenile Board on behalf of Tarrant County Juvenile Services**, located at **2701 Kimbo Road Fort Worth, Texas 76111** ("Customer") desires to establish the License Agreement entered into by Licensor and Customer commencing on **July 31, 2023** for the use of an Internet based learning management system and curriculum entitled Edgenuity® , including Digital Libraries 6-12 Comprehensive All Site License (MS and HS content for math, ELA, science, social studies, electives, AP, world languages, Virtual Tutors; excludes eDynamic Learning and Purpose Prep), Digital Libraries Enhanced CTE, Edgenuity Academic Integrity-Includes Plagiarism Checker and Speed Radar, IS 6-12 on-Demand Tutoring, and Professional Development Webinar Training and all of its components including but not limited to data, software, technology, animation, photographs, graphic, audio and visual files, text, platform, documentation and any and all related materials (collectively hereinafter referred to as the "Application").

The Agreement provides for a Term of one Year ("Term").

Each Renewal Term shall commence upon the expiration of the then in effect initial Term or Renewal Term, as applicable. The Initial Term and any Renewal Term shall be collectively referred to as the "TERM".

The Licensor verifies that it does not boycott Israel and will not boycott Israel during the term of this contract.
