FIRST AMENDMENT TO THE AGREEMENT BETWEEN TARRANT COUNTY AND THE EIGHTH ADMINISTRATIVE JUDICIAL REGION

Tarrant County and the Eighth Administrative Judicial Region of the State of Texas (collectively, the "Parties"), now wish to amend the Agreement originally entered into by the Parties on November 18, 2014, relating to the assignment of an Administrative Assistant to the Presiding Judge of the Eighth Administrative Judicial Region by Tarrant County to include an Auxiliary Court Coordinator.

RECITALS

WHEREAS, on November 18, 2014, through Court Order 118977, Tarrant County approved an agreement with the Eighth Administrative Judicial Region; and

WHEREAS, the Parties wish to amend that agreement to provide an Auxiliary Court Coordinator to the Eighth Administrative Judicial Region.

NOW, THEREFORE, the Parties agrees as follows:

I

Paragraph I of the Agreement shall be amended to read as follows:

Tarrant County, Texas, acting through its County Administrator, shall assign an Administrative Assistant and a part-time Auxiliary Court Coordinator, to the Presiding Judge of the Eighth Administrative Judicial Region of the State of Texas to perform the functions enumerated in TEX. GOV'T CODE § 74.050, as authorized by the Presiding Judge. The name, job designation, and Tarrant County employee number of the Administrative Assistant and part-time Auxiliary Court Coordinator are attached hereto as Schedule A.

II

Paragraph II of the Agreement shall be amended to read as follows:

The Administrative Assistant and part-time Auxiliary Court Coordinator's salary, benefits and other expenses shall be paid from funds of the Eighth Administrative Judicial Region.

III

Paragraph III of the Agreement shall be amended to read as follows:

Tarrant County shall not be liable for any funds beyond those assessments of counties in the Eighth Administrative Judicial Region, pursuant to the Texas Government Code, for the cost of the Administrative Assistant or part-time Auxiliary Court Coordinator, who will remain Tarrant County employees with all the same rights, tenure, and benefits now enjoyed or hereafter granted to Tarrant County employees, subject to the provisions of TEX. Gov' T CODE § 74.101.

IV

Paragraph IV of the Agreement shall be amended to read as follows:

The Tarrant County Auditor will invoice on a monthly basis the Eighth Administrative Judicial Region for the cost of the Administrative Assistant and part-time Auxiliary Court Coordinator.

V

Schedule A as attached to the Agreement shall be superseded by the modified Schedule A as attached to this Amendment.

VI

This Amendment supersedes any and all previous agreements for the subject matter specified herein, whether oral or written.

VII

The effective date of this Amendment is the 19th day of September, 2023.
