**INTERLOCAL AGREEMENT BETWEEN
TARRANT COUNTY AND THE TARRANT COUNTY
EMERGENCY SERVICES DISTRICT NO. 1 FOR OFFICE
SPACE AND LIMITED ADMINISTRATIVE SERVICES**

COUNTY OF TARRANT

WHEREAS, this agreement is made on the date of the last party's signature to this agreement and is between County of Tarrant, Texas, hereinafter referred to as COUNTY, and the Tarrant County Emergency Services District No. 1, hereinafter referred to as DISTRICT; and

WHEREAS, this agreement is made pursuant to the authority of Chapter 791 of the Texas Government Code; and

WHEREAS, the expenses of any payments or performance required by this agreement shall come from current revenues legally available to the parties; and

WHEREAS, the subject of this contract is necessary for the benefit of the public and each party has the legal authority to perform and to provide the governmental function or service which is the subject matter of this contract; and

WHEREAS, the parties find the performance of this agreement is in the common interest of both parties, and the performance and payment fairly compensates both parties; and

WHEREAS, the purpose of this Agreement is for the facilitation of the property and convenient location for the offices of the DISTRICT and the management of said location.

NOW THEREFORE, the COUNTY, acting by and through its governing body, and the DISTRICT, acting by and through its governing body, agree as to the following;

1. COUNTY agrees to make available to the DISTRICT, to the extent needed by DISTRICT, the office space located at 2750 Premier Street, Fort Worth, Tarrant County, Texas.
2. The DISTRICT will pay to the COUNTY the employment salary expense of a full-time office manager including the employer contribution for the following: health care, life insurance, retirement, flexible spending account, social security and other employer contributions paid on behalf of the County employees.
3. The DISTRICT will not pay more than \$89,220.58 during the term of this agreement.
4. The DISTRICT shall supervise the office manager while in performance of duties for the DISTRICT.
5. The COUNTY may aid the DISTRICT, under the direction of the DISTRICT'S Investment Officer, in performing the DISTRICT'S duties under Chapter 2256, Texas Government Code (Public Funds Investment Act). Other than the office manager and accountant considered as part of this Agreement, the duties assumed by other COUNTY employees will be agreed to by both parties.
6. The term of this agreement shall be October 1, 2023, through September 30, 2024. This Agreement may be terminated for any reason by either party to this Agreement upon thirty (30) days written notice to the other party. Notice will be accomplished on the date of receipt of said notice.
