#### DEPARTMENT OF STATE HEALTH SERVICES CONTRACT NO. HHS000897700004 AMENDMENT NO. 4

The Department of State Health Services ("DSHS" or "System Agency") and Tarrant County ("Grantee"), each a "Party" and collectively the "Parties" to DSHS Contract No. HHS000897700004 (the "Contract"), effective October 5, 2020, now desire to amend the Contract further.

**Whereas**, the Parties have chosen to exercise their option to amend the Contract in accordance with Section 9.1 of Attachment C to the Contract; and

**Whereas,** the Parties desire to change the termination date of the Contract to May 31, 2024, adjust available funding, and revise the budget accordingly.

**Now, Therefore**, the Parties hereby amend and modify the Contract as follows:

- 1. **ARTICLE III** of the Contract, **DURATION**, is hereby amended to reflect a revised termination date of May 31, 2024, unless terminated sooner.
- 2. **ARTICLE IV** of the Contract, **BUDGET**, is amended to reduce available funding for the period of August 1, 2023, through May 31, 2024, from \$637,328.00 to \$531,106.00.

The total not-to-exceed amount of this Contract is reduced to \$2,210,890.00.

All expenditures shall be in accordance with ATTACHMENT B-4, REVISED BUDGET.

- 3. **ATTACHMENT B-3** of the Contract, **REVISED BUDGET**, is amended and restated as shown in **ATTACHMENT B-4**, **REVISED BUDGET**.
- 4. **ATTACHMENT A, STATEMENT OF WORK,** is supplemented with the following updated reporting requirements for the period of August 1, 2023, through May 31, 2024.
