Purpose

This Memorandum of Understanding (MOU), between the City of Arlington, on behalf of Arlington Landmark Preservation Commission, and Tarrant County, on behalf of the Tarrant County Office of Historic Preservation, is entered into for the purpose of utilizing Arlington Landmark Preservation Commission's 2007 Historic Resources Survey data in the Tarrant County Office of Historic Preservation's historic resources GIS map. This agreement is entered into on the signature date of the final party to execute the MOU.

Responsibilities of the Parties

Arlington Landmark Preservation Commission and the Tarrant County Office of Historic Preservation understand that each should be able to fulfill its responsibilities under this Memorandum of Understanding.

City of Arlington Landmark Preservation Commission responsibilities:

1. Will provide the 2007 City of Arlington Historic Resources Survey data to the Tarrant County Office of Historic Preservation.

Tarrant County Office of Historic Preservation responsibilities:

1. Will incorporate all provided data into the GIS map of historic resources in Tarrant County.
2. Will not edit historic resources information in data provided, but may add additional information, geocoding, or similar as needed.
3. Will make this data available on the Tarrant County Historic Preservation webpage via a GIS map.
4. Will credit the City of Arlington on the Tarrant County Historic Preservation webpage for the data provided.

Term and Termination

The term of this Agreement shall begin upon the signature date of the final party to execute the agreement and shall continue for a term of (5) five years, which shall automatically renew unless terminated by the action of either party.

Termination Without Cause

This Agreement may be terminated by either party upon 30 days prior written notice to the other party.
