AMENDMENT NO. 1

WHEREAS, on March 7, 2023 (Court Order No. 140401), the Tarrant County Commissioners Court ("COUNTY") approved an architectural and engineering contract ("Contract") with Komatsu Architecture, Inc. ("PROVIDER") for the Tarrant County Law Enforcement Training Center Feasibility Study and

NOW, THEREFORE, the COUNTY and PROVIDER hereby agree to the following Amendment No. 1 to the Agreement, for additional architectural and engineering services by Komatsu Architecture, Inc. as requested by the owner during the design phase of the project. Amendment No. 1 reflects the additional service compensation to cover work described within this proposal, said renovations to be defined by COUNTY and mutually agreed to by PROVIDER. PROVIDER shall be responsible for ensuring its compliance with any laws and regulations applicable to its business, including maintaining any necessary licenses and permits.
