

## **RESOLUTION NO. 1110-2023**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVER OAKS, TEXAS RENEWING THE FUNDING INTERLOCAL AGREEMENTS IN ORDER TO CONTINUE FUNDING FOR THE PROJECTS FUNDED THROUGH THE TARRANT COUNTY 2006 TRANSPORTATION BOND PROGRAM (TBP) AUTHORIZING THE MAYOR TO EXECUTE THE INDIVIDUAL FUNDING INTERLOCAL AGREEMENTS FOR LONG AVENUE AND ALMENA ROAD RECONSTRUCTION, ROBERTS CUT OFF ROAD RECONSTRUCTION, AND MERRITT STREET RECONSTRUCTION PROJECTS; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City of River Oaks is a home rule city acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, Tarrant County and the City of River Oaks entered a Funding Interlocal Agreement (ILA) on December 13, 2022 by Commissioners Court Order No. 139978 for financial support up to \$295,315.00 through the Tarrant County 2006 Transportation Bond Program (TBP) for reconstruction and asphalt overlay of Long Avenue from River Oaks Blvd to Jacksboro Highway, reconstruction and asphalt overlay of Almena Road from Long Avenue to Byrd Street and asphalt overlay of Almena Road from Byrd Street to Shenna Boulevard; and

WHEREAS, Tarrant County and the City of River Oaks entered a Funding Interlocal Agreement (ILA) on September 7, 2021 by Commissioners Court Order No. 136281 and Renewal and Amendment No. 1 on November 1, 2022 by Commissioners Court Order No. 139605 for financial support up to \$453,281.00 through the Tarrant County 2006 Transportation Bond Program (TBP) for reconstruction and asphalt overlay of the Roberts Cut Off Road from Skyline Drive to the north city limits and from Blackstone Drive to River Oaks Boulevard (SH 183); and

WHEREAS, Tarrant County and the City of River Oaks entered a Funding Interlocal Agreement (ILA) on January 25, 2022 by Commissioners Court Order No. 137347 and Amendment No. 1 on November 1, 2022 by Commissioners Court Order No. 139604 for the financial support up to \$163,563.00 through the Tarrant County 2006 Transportation Bond Program (TBP) for reconstruction and asphalt overlay of Merritt Street from Barbara Road to River Oaks Boulevard (SH 183); and

WHEREAS, the City of River Oaks and Tarrant County desires to renew these Interlocal Agreements under the Tarrant County 2006 Transportation Bond Program (TBP) in order to continue funding for the Projects as herein attached to this Resolution; and

WHEREAS, with the adoption of this Resolution, the Mayor has been authorized to execute the individual Funding Interlocal Agreements for Long Avenue and Almena Road reconstruction, Roberts Cut Off Road reconstruction, and Merritt Street reconstruction projects.

**NOW, THEREFORE, BE IS RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS, TEXAS:**

**I.**

With the adoption of this Resolution Tarrant County and the City of River Oaks desire to renew and approve funding interlocal agreements for the financial support through the Tarrant County 2006 Transportation Bond Program (2006 TBP) for reconstruction and asphalt overlay projects involving streets located within the City of River Oaks as follows:

- **Long Avenue and Almena Rd Reconstruction:** Renewal & Amendment # 1 of Interlocal Agreement; and
- **Roberts Cut Off Rd. Reconstruction:** Renewal & Amendment # 2 of Interlocal Agreement; and
- **Merritt Street Reconstruction:** Renewal & Amendment # 2 of Interlocal Agreement.

**II.**


With the adoption of this Resolution, the Mayor has been authorized to execute the individual Funding Interlocal Agreements for Long Avenue and Almena Road reconstruction, Roberts Cut Off Road reconstruction and Merritt Street reconstruction projects.


**III.**
