MHMR of Tarrant County is the second-largest community center in Texas.

- Intellectual & Developmental Disabilities (IDD) for youth and adults
- Substance Use Disorders for youth and adults



Our goal...


To provide an alternative for law enforcement who encounter people engaging in illegal behavior that is the result of or related to a mental health crisis.





#### Who is Eligible?

- Brought in by Law Enforcement Officers
- Non-violent misdemeanor offense
  - Criminal trespass
  - Theft
  - Possession of marijuana
  - Disorderly conduct
  - False report
  - Terroristic threat (with no violence)
- Mental/behavioral health needs
- Willing to Participate





# Who is Ineligible?

- No aggressive or violent patients
- No patients experiencing medical emergencies
- No patients experiencing mental health crises that require emergency care





#### How does it work?

•An officer encounters a person who meets the criteria.

•The officer chooses to take the person to the Diversion Center instead of jail.

No charges are filed, and the person's stay is voluntary.

It takes less than five minutes for an officer to drop off a guest. The patient will receive treatment for immediate behavioral health and medical needs.

The average stay is 72 hours.

Diversion Center staff will connect the patient with resources and aftercare in the community.

Diversion Center staff will provide case management in the community for up to a year after departure.



## Benefits of the Mental Health Jail Diversion Center?

- Increased access to treatment and services in the community
- Reduction in booking time for officers on patrol
- Reduction in exposure to risk associated with confinement
- Provides Officers a way to connect non violent offenders to Services
- It's the right thing to do



## **DeAndre**

DeAndre came to the MH Jail Diversion Center and, at that time, was hesitant to talk to staff about his current situation. DeAndre didn't know where his life was headed but knew he wanted a change. Our peers, case managers and patient care technicians began to engage and connect with him. After a few days, DeAndre opened up and expressed his short term and long-term goals. He indicated he was going through turmoil and prayed to God for a blessing. The MH Jail Diversion Center was his blessing.

Through the Diversion Center and the efforts of his transitional peer and case manager, DeAndre was able to obtain critical documents which also led to secured housing and stability. The MHJDC staff worked closely with one of the MHMR housing programs to provide DeAndre with the most appropriate housing solution. This program will support independent living through housing and mental health case management, peer support services and a rental subsidy for up to 12 months. **DeAndre moved into his own apartment on August 1, 2023**.

Not only did DeAndre move into an apartment, but he also obtained employment. His peer specialist provided employment resources, resume writing tips and transported DeAndre to employment interviews. He was offered a job at a local restaurant and will begin training this week.

DeAndre called last week to thank the staff at MHJDC for helping him to overcome obstacles by giving him hope and encouragement. He also expressed how supported he feels as a guest in our transitional program. One last quote from DeAndre. "My world finally feels complete, and I owe that to y'all."
