SUBJECT: APPROVAL OF AMENDMENT NO. 4 TO THE INTERLOCAL COOPERATION CONTRACT BETWEEN TARRANT COUNTY AND THE DEPARTMENT OF STATE HEALTH SERVICES FOR THE NORTH TEXAS SYNDROMIC SURVEILLANCE PROGRAM

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 4 to the Interlocal Cooperation Contract, HHS00069620001, between Tarrant County Public Health (TCPH) and the Department of State Health Services (DSHS) for the North Texas Syndromic Surveillance (NTXSS) Program.

BACKGROUND

On January 28, 2020, the Commissioners Court, through Court Order #132017, approved the Interlocal Cooperation Contract between TCPH and DSHS for the NTXSS program which provided \$250,153.00 for federal FY 2020.

On April 14, 2020, the Commissioners Court, through Court Order #132596, approved Amendment No. 1 to the contract, adding federal FY 2021 funding in the amount of \$250,153.00 for an amended not-to-exceed amount of \$500,306.00.

On November 10, 2020, the Commissioners Court, through Court Order #134209, approved Amendment No. 2 to the contract, decreasing the FY 2021 budget by \$3,255.00 for an amended not-to exceed amount of \$497,051.00.

On April 27, 2021, the Commissioners Court, through Court Order #135326, approved Amendment No. 3 to the contract, extending the contract through July 31, 2022 and adding \$250,173.00 to the contract for FY 2022 for an amended not-to-exceed amount of \$747,224.00.

With approval of Amendment No. 4, the contract termination date will be extended to July 31, 2023 and \$250,173.00 will be added to the contract for FY 2023 for an amended not-to-exceed amount of \$997,397.00. The attachments and Statement of Work are amended accordingly. There is no match amount required for this contract.

All other terms and conditions not hereby amended remain in full force and effect.
