## **BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred (100) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Eight (8) bids were received.

Bids were evaluated by Purchasing representatives. Award recommendations are the low bids meeting specifications.

The bid received from Global Industrial was deemed non-responsive for failure to provide item pricing per bid specifications.

There were no secondary or alternate awards on Sections 1, 7, and 8 because only one (1) response was received for each section. No alternate was awarded on Sections 4 and 5 because only two (2) responses were received for each section.

Tie bids were received for the Items in Section 2. The award recommendations were determined in accordance with Commissioners Court Order No. 60616, Procedure for Awarding Tie Bids.

The term of the contract is twelve (12) months, effective April 5, 2022, with two (2) options for a renewal period of twelve (12) months each.

Therefore, it is the recommendation of Purchasing that Bid No. 2022-084, Annual Contract for Miscellaneous Office Furniture, be awarded to the vendors listed above at the per unit price and discount from list price.

### **FISCAL IMPACT**

Expenses for last year were approximately \$515,840.75. Orders are placed on an as-needed basis.
