#### **COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve RFO No. 2022-132, Purchase of Radio Accessories, utilizing the State of Texas Department of Information Resources (DIR) contracts #DIR-TSO-3980 and #DIR-TSO-4101, for Information Technology, to the following vendors for \$84,715.42:

## BACKGROUND

Forty-seven (47) vendors who offer radio accessories under cooperative contracts were contacted and requested to provide written offers. Two (2) offers were received.

The low offers received from American Communications and Motorola Solutions, Inc. meet all specifications and are acceptable to Information Technology.

American Communications and Motorola Solutions, Inc. offer radio accessories through DIR contracts #DIR-TSO-3980 and #DIR-TSO-4101. The radio accessories are for the refresh and replacement of public safety radios in the County. This is the first purchase of a multi-year refresh plan to update all radios to current and supported models.

DIR Contract DIR-TSO-3980 expires on September 8, 2022. DIR Contract DIR-TSO-4101 expires on April 24, 2023.

DIR's cooperative contracts program is open for state and local government in accordance with Government Code Title 10, Subtitle B, Chapter 2054, Subchapter A, Section 2054.0565, Use of Contracts by Other Entities, "(a) The department may include terms in a procurement contract entered into by the department, including a contract entered into under Section 2157.068, that allow the contract to be used by another state agency, a political subdivision of this state, a governmental entity of another state, or an assistance organization as defined by Section 2175.001. (b) A political subdivision that purchases an item or service using a contract under this section satisfies any other law requiring the political subdivision to seek competitive bids for that item or service".
