BACKGROUND

Notice of the County's intent to request for qualifications was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Fifty-one (51) vendors were contacted and requested to participate in this process. All documents pertaining to this RFQ were posted on the Tarrant County website and were downloaded by interested parties. Thirteen (13) responses were received.

Responses were evaluated by Transportation Services, Facilities Management, and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFQ.

The responses received from the vendors listed above meet all specifications and are acceptable to Transportation Services and Facilities Management.

The term of the contract is twelve (12) months, effective August 22, 2022, with four (4) options for renewal periods of twelve (12) months each.
