**SUBJECT: APPROVAL OF AMENDMENT NO. 2 TO TWO FISCAL YEAR 2022-2023 HEALTH RESOURCES AND SERVICES ADMINISTRATION RYAN WHITE TREATMENT EXTENSION ACT PART A SUBRECIPIENT CONTRACTS WITH TARRANT COUNTY HOSPITAL DISTRICT AND THE SALVATION ARMY – MABEE SOCIAL SERVICE – HIV ADMINISTRATIVE AGENCY**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Amendment No. 2 to two (2) Fiscal Year 2022-2023 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A subrecipient contracts with Tarrant County Hospital District and The Salvation Army – Mabee Social Service.

**BACKGROUND**

On January 25, 2022, the Commissioners Court, through Court Order #137306, approved the FY 2022-2023 Notice of Award for the Ryan White Part A grant contract in the amount of \$1,616,841.00.

On June 7, 2022, the Commissioners Court, through Court Order #138261, approved Amendment No. 1 to the FY 2022-2023 Ryan White Part A Final Notice of Award in the amount of \$3,564,395.00, increasing funding to \$5,181,236.00.

On April 5, 2022, the Commissioners Court, through Court Order #137812, approved the FY 2022-2023 contract renewal with Tarrant County Hospital District and The Salvation Army – Mabee Social Service.

With approval of Amendment No. 2 to the contracts, funding will increase in several categories.

The term of this community subrecipient contract is March 1, 2022 through February 28, 2023.

The recommended contracts are as follows:

Tarrant County Hospital District – Total reimbursement shall not exceed \$1,449,179.00

The Salvation Army – Mabee Social Service – Total reimbursement shall not exceed \$295,237.00
