BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Eighty-one (81) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on August 18, 2022 was attended by two (2) vendors as well as representatives from Transportation Services and Purchasing. Five (5) bids were received.

Bids were evaluated by Transportation Services and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Randall Reed's Planet Ford 635 withdrew their response for Item 91. Grapevine DCJ, LLC withdrew their entire bid response. There are no awards for items 1, 2, 8, 13-18, 23-28, 35, 36, 39, 40, 43, 44, 63-66, 71-74, 87-90, 103-106, 135, 138, 156, 157, and 167 because only no-bids were received for these items.

The term of the contract is twelve (12) months, effective October 7, 2022, with one (1) option for a renewal period of twelve (12) months.
