**BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred twelve (112) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on August 17, 2022 was attended by one (1) vendor as well as representatives from Precincts 1 and 2 and Purchasing. Four (4) bids and one (1) no-bid were received.

Bids were evaluated by Precincts 1 and 2 and Purchasing representatives. Award recommendations are to all bids meeting specifications.

The term of the contract is twelve (12) months, effective October 30, 2022, with two (2) options for renewal periods of twelve (12) months each.

Therefore, it is the joint recommendation of Precincts 1 and 2 and Purchasing that Bid No. 2022-191, Annual Contract for Asphalt Road Surfacing Products, be awarded to the vendors listed above at the per unit price.
