SUBJECT: APPROVAL OF AMENDMENTS TO SUBRECIPIENT AGREEMENTS BETWEEN TARRANT COUNTY AND ARLINGTON LIFE SHELTER, FAMILY PATHFINDERS OF TARRANT COUNTY, GRAPEVINE RELIEF AND COMMUNITY EXCHANGE, PRESBYTERIAN NIGHT SHELTER, AND RECOVERY RESOURCE COUNCIL AS PART OF THE TARRANT COUNTY FISCAL RECOVERY FUNDS PROGRAM

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve amendments to subrecipient agreements between Tarrant County and Arlington Life Shelter, Family Pathfinders of Tarrant County, Grapevine Relief and Community Exchange, Presbyterian Night Shelter, and Recovery Resource Council as part of the Tarrant County Fiscal Recovery Funds Program.

BACKGROUND

On March 1, 2022, the Commissioners Court, through Court Order #137524, approved the Tarrant County Fiscal Recovery Funds (FRF) Program Budget, including \$1,205,000 for the Tarrant County Housing Finance Corporation (HFC) Partnerships program.

On February 8, 2022, the Commissioners Court, through Court Order Nos. 137436, 137438, and 137449, approved subrecipient agreements with Grapevine Relief and Community Exchange, Family Pathfinders of Tarrant County, and Recovery Resource Council, respectively.

On March 8, 2022, the Commissioners Court, through Court Order Nos. 137629 and 137632, approved subrecipient agreements with Arlington Life Shelter and Presbyterian Night Shelter, respectively.

As a result of this action, the award amount for each of the aforementioned subrecipient agreements will be increased by the amount show below:
