**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve two (2) FY 2022-2023 Health Resources and Services Administration (HRSA) Ending the HIV Epidemic: A Plan for America - Ryan White HIV/AIDS Program Part A and B Subrecipient Contract renewals with CAN Community Health, Inc. and Tarrant County Hospital District.

**BACKGROUND**

On March 1, 2022, the Commissioners Court, through Court Order #137539, approved the HRSA FY 2022-2023 partial Notice of Award for the Ending the Epidemic: A Plan for America – Ryan White HIV/AIDS Program Part A and B grant contract in the amount of \$238,008.00.

On June 28, 2022, the Commissioners Court, through Court Order #138444, approved Amendment No. 1 to the HRSA FY 2022-2023 Ending the Epidemic: A Plan for America – Ryan White HIV/AIDS Program Part A and B in the amount of \$961,992.00, bringing full award to \$1,200,000.00.

The term of this community subrecipient contract is March 1, 2022 through February 28, 2023.

The recommended contract is as follows:

CAN Community Health Inc. – Total reimbursement shall not exceed \$84,071.90.

Tarrant County Hospital District – Total reimbursement shall not exceed \$313,388.10.

The Criminal District Attorney's Office has reviewed these documents as to form.

**FISCAL IMPACT**

All associated costs will be paid from grant allocations in grant account 569013/Grant-2004/1132200000/E0024-2023.
