**SUBJECT: APPROVAL OF AMENDMENT NO. 3 TO THE FISCAL YEAR 2022-2023 HEALTH RESOURCES AND SERVICES ADMINISTRATION RYAN WHITE TREATMENT EXTENSION ACT PART A SUBRECIPIENT CONTRACT WITH AIDS OUTREACH CENTER – HIV ADMINISTRATIVE AGENCY**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Amendment No. 3 to the Fiscal Year 2022-2023 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A Subrecipient Contract with AIDS Outreach Center.

**BACKGROUND**

On January 25, 2022, the Commissioners Court, through Court Order #137306, approved the FY 2022-2023 Notice of Award for the Ryan White Part A grant contract in the amount of \$1,616,841.00.

On June 7, 2022, the Commissioners Court, through Court Order #138261, approved Amendment No. 1 to the Fiscal Year 2022-2023 Ryan White Part A Final Notice of Award for additional funding in the amount of \$3,564,395.00, bringing total funding to \$5,181,236.00.

On April 5, 2022, the Commissioners Court, through Court Order #137812, approved the FY 2022-2023 contract renewal with AIDS Outreach Center.

On September 27, 2022, the Commissioners Court, through Court Order #139240, approved Amendment No. 2 to the Fiscal Year 2022-2023 Ryan White Part A Notice of Award for additional funding in the amount of \$24,302.00, bringing total funding to \$5,205,538.00.

Over the grant year, the subrecipient contract has been amended to reflect changes in verbiage as well as increases and decreases in funding.

With approval of Amendment No. 3 to the contract, funding will increase by \$24,302.00.

The term of this community subrecipient contract is March 1, 2022 through February 28, 2023.

The recommended contract is as follows:

AIDS Outreach Center – Total reimbursement shall not exceed \$1,384,324.00
