BACKGROUND

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Two hundred sixty-two (262) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Six (6) bids were received.

Bids were evaluated by Public Health and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

There are no alternate awards for items 4 and 5 because the next lowest bidder meeting specifications, Diagnostic Direct, LLC, is not willing to accept secondary or alternate award. There are no alternate awards for item 8 and 9 because only two (2) bids were received for these items.

The term of the contract is twelve (12) months, effective January 14, 2023, with one (1) option for a renewal period of twelve (12) months.
