COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 3 to two (2) Fiscal Year 2022-2023 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A subrecipient contracts with Tarrant County Hospital District and Tarrant County Samaritan Housing, Inc.

BACKGROUND

On January 25, 2022, the Commissioners Court, through Court Order #137306, approved the FY 2022-2023 Notice of Award for the Ryan White Part A grant contract in the amount of \$1,616,841.00

On June 07, 2022, the Commissioners Court, through Court Order #138261, approved Amendment No. 1 to the Fiscal Year 2022-2023 Ryan White Part A Final Notice of Award in the amount of \$3,564,395.00. With this amendment, the Ryan White Part A funding increased to \$5,181,236.00.

On March 15, 2022, the Commissioners Court, through Court Order #137695, approved the FY 2022-2023 contract renewal with Tarrant County Samaritan Housing, Inc.

On April 5, 2022, the Commissioners Court, through Court Order #137812, approved the FY 2022-2023 contract renewal with Tarrant County Hospital District.

Over the grant year, subrecipient contracts are amended to reflect changes in verbiage as well as increases and decreases in funding.

With approval Amendment No. 3 to the Subrecipient Contracts, funding will increase and decrease in several service categories.

The term of the Subrecipient Contracts is March 1, 2022 through February 28, 2023.
