It is requested that the Commissioners Court approve exceptions to Tarrant County's fee schedule for interpreters appointed by Criminal Courts.

**BACKGROUND**

On December 8, 1988, the Commissioners Court, through Court Order #79732, established an amount of \$50.00 per hour for court interpreters. On November 17, 2020, through Court Order #134246, the hourly rate for court interpreters was increased to \$100.00 per hour. Interpreter fees incurred prior to November 17, 2020, will adhere to the \$50.00 per hour rate.
