BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred eighty-four (184) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Eleven (11) bids and one (1) no-bid were received.

Bids were evaluated by Budget and Risk Management, Facilities Management, and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

AED Brands LLC withdrew their bid for Items 17 and 19 and Uncharted Territory LLC withdrew their bid for Items 1 and 10 due to pricing errors.
