SUBJECT: **APPROVAL OF AMENDMENT NO. 3 TO THE FISCAL YEAR 2022-2023 HEALTH RESOURCES AND SERVICES ADMINISTRATION RYAN WHITE TREATMENT EXTENSION ACT PART A SUBRECIPIENT CONTRACT WITH TARRANT COUNTY PREVENTIVE MEDICINE CLINIC – HIV ADMINISTRATIVE AGENCY**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 3 to the FY 2022-2023 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A Subrecipient Contract with Tarrant County Preventive Medicine Clinic.

BACKGROUND

On January 25, 2022, the Commissioners Court, through Court Order #137306, approved the receipt of the FY 2022-2023 Notice of Award for the Ryan White Part A grant contract in the amount of \$1,616,841.00. The goal of Ryan White Part A is to provide optimal HIV care and treatment for people with HIV who are low-income, uninsured, and underserved, to improve their medical outcomes.

On June 7, 2022, the Commissioners Court, through Court Order #138261, approved Amendment No. 1 to the FY 2022-2023 Ryan White Part A Final Notice of Award in the amount of \$3,564,395.00, bringing Ryan White Part A funding to \$5,181,236.00.

On April 5, 2022, the Commissioners Court, through Court Order #137812, approved the FY 2022-2023 contract renewal with Tarrant County Preventive Medicine Clinic.

Over the grant year, subrecipient contracts are amended to reflect changes in contract language as well as increases and decreases in funding.

With approval of Amendment No. 3 to the contract, funding will decrease for Medical Case Management by \$11,000.00.

The term of this community subrecipient contract is March 1, 2022 through February 28, 2023.

The recommended contract is as follows:

Tarrant County Preventive Medicine Clinic – Total reimbursement shall not exceed \$586,495.00
