SUBJECT: APPROVAL OF AMENDMENT NO. 1 TO THE FISCAL YEAR 2022-2023 TEXAS DEPARTMENT OF STATE HEALTH SERVICES RYAN WHITE TREATMENT EXTENSION ACT PART B HIV SERVICES SUBRECIPIENT CONTRACT WITH TARRANT COUNTY PREVENTIVE MEDICINE CLINIC – HIV ADMINISTRATIVE AGENCY

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 1 to the Fiscal Year 2022-2023 Texas Department of State Health Services (DSHS) Ryan White Treatment Extension Act Part B HIV Services subrecipient contract with Tarrant County Preventive Medicine Clinic.

BACKGROUND

Tarrant County receives yearly support from Texas DSHS, in the form of grant contracts, to perform a variety of essential public health services.

On February 8, 2022, the Commissioners Court, through Court Order #137447, approved the FY 2022-2023 Texas DSHS Ryan White Treatment Extension Act Part B HIV Services Grant Contract renewal for a total of \$1,718,966.00 in grant funding.

As part of Tarrant County's responsibility as Administrative Agency for this grant contract, a network of subrecipients is maintained to support treatment and care for HIV-positive individuals in the HIV Services Delivery Area (HSDA).

On April 26, 2022, the Commissioners Court, through Court Order #137965, approved the FY 2022-2023 Subrecipient Contract renewal with Tarrant County Preventive Medicine Clinic.

With approval of Amendment No. 1 to the Subrecipient Contract, funding will increase in Emergency Financial Assistance by \$9,487.00 and decrease in Referral for Health Care and Support Services by \$9,487.00.

The term of this Subrecipient Contract is April 1, 2022 through March 31, 2023.

The recommended contract is as follows:

Tarrant County Preventive Medicine Clinic – Total reimbursement shall not exceed \$150,844.00.
