**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve the FY 2023-2024 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A Subrecipient Contract renewal with Tarrant County Samaritan Housing, Inc.

**BACKGROUND**

Since 1996, Tarrant County has been awarded funding under the Ryan White HIV/AIDS Program (RWHAP) Part A HIV Emergency Relief Grant Program. The purpose of this program is to provide direct financial assistance to the Fort Worth/Arlington Transitional Grant Area (TGA) to develop and enhance access to a comprehensive continuum of high-quality, community-based care and treatment for low-income individuals living with HIV. This is accomplished through the provision of Formula, Supplemental, and Minority AIDS Initiative (MAI) funds. Tarrant County HIV Administrative Agency administers the grant funding through subcontracts with community organizations that then deliver the necessary high-quality services. Tarrant County Samaritan Housing, Inc. is a participating subrecipient.

On January 31, 2023, the Commissioners Court, through Court Order #140205, approved the FY 2023-2024 HRSA Notice of Award for the Ryan White Part A Grant Contract in the amount of \$895,593.00.

The project period for the RWHAP Grant is March 1, 2022 through February 28, 2025. The term of this community subrecipient contract is March 1, 2023 through February 29, 2024.

The recommended contract is as follows:

Tarrant County Samaritan Housing, Inc. – Total reimbursement shall not exceed \$26,293.00
