BACKGROUND

On May 24, 2022, the Commissioners Court, through Court Order #138223, awarded Bid No. 2022-118, Annual Contract for Trackless Tack Emulsion, Countywide, to the following vendors:

	Texas Materials Group, Inc. d/b/a TexasBit	Section 2

The awards were based upon low bid meeting specifications and contained options to renew for two (2) additional twelve (12) month periods.

Ergon Asphalt & Emulsions, Inc. elected not to renew. The remaining vendors notified Purchasing in writing that their prices will remain firm through June 5, 2024. The four (4) Maintenance Precincts notified Purchasing in writing that they are pleased with the vendors and want to renew.

Therefore, it is the joint recommendation of the four (4) Maintenance Precincts and Purchasing that the Commissioners Court approve renewal of Bid No. 2022-118, Annual Contract for Trackless Tack Emulsion, for another twelve (12) month period.
