## COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve the FY 2023-2024 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A Subrecipient Contract renewal with AIDS Healthcare Foundation (AHF).

## **BACKGROUND**

Since 1996, Tarrant County has been awarded funding under the Ryan White HIV/AIDS Program (RWHAP) Part A HIV Emergency Relief Grant Program. The purpose of this program is to provide direct financial assistance to the Fort Worth/Arlington Transitional Grant Area (TGA) to develop and enhance access to a comprehensive continuum of high-quality, community-based care and treatment for low-income individuals living with HIV. This is accomplished through the provision of Formula, Supplemental, and Minority AIDS Initiative (MAI) funds. Tarrant County HIV Administrative Agency administers the grant funding through subcontracts with community organizations that then deliver the necessary high-quality services.

AHF is a community-based medical clinic that delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care and prescription assistance.

On February 07, 2023, the Commissioners Court, through Court Order #140205, approved the FY 2023-2024 HRSA Notice of Award for the Ryan White Part A grant contract in the amount of \$895,593.00.

The Part A grant project period is March 1, 2022 through February 28, 2025. The term of the contract period is March 1, 2023 through February 29, 2024.

The recommended contract is as follows:

AIDS Healthcare Foundation – Total reimbursement shall not exceed \$96,904.00
