DEPARTMENT OF STATE HEALTH SERVICES RYAN WHITE TREATMENT EXTENSION ACT PART B SUBRECIPIENT CONTRACT RENEWALS WITH AIDS HEALTHCARE FOUNDATION AND TARRANT COUNTY PREVENTIVE MEDICINE CLINIC – HIV ADMINISTRATIVE AGENCY

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve two (2) Fiscal Year (FY) 2023-2024 Texas Department of State Health Services (DSHS) Ryan White Treatment Extension Act Part B (Part B) subrecipient contract renewals with AIDS Healthcare Foundation (AHF) and Tarrant County Preventive Medicine Clinic (PMC).

BACKGROUND

Texas DSHS provides annual Ryan White Treatment Extension Act Part B (Part B) grant contract funding to support the provision of essential health and support services to HIV-positive individuals.

On February 7, 2023, the Commissioners Court, through Court Order #140209, approved the FY 2023-2024 Texas DSHS Part B HIV Services grant contract renewal in the amount of \$1,320,878.00.

AHF is a community-based medical clinic that delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care and prescription assistance.

PMC is a HIV medical clinic that is part of and located within Tarrant County Public Health (TCPH). PMC delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care, prescription assistance, and medical case management.

The Part B project period is April 1, 2022, through March 31, 2024. The term of this contract is April 1, 2023, through August 31, 2023.

The recommended contracts are as follows:

AIDS Healthcare Foundation – Total reimbursement shall not exceed \$47,625.00.

Tarrant County Preventive Medicine Clinic – Total reimbursement shall not exceed \$51,927.00.
