**SUBJECT: APPROVAL OF AMENDMENT NO. 4 TO THE FISCAL YEAR 2021-2022 HEALTH RESOURCES AND SERVICES ADMINISTRATION NOTICE OF AWARD FOR RYAN WHITE TREATMENT EXTENSION ACT PART A GRANT – HIV ADMINISTRATIVE AGENCY**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Amendment No. 4 to the Health Resources and Services Administration (HRSA) FY 2021-2022 Notice of Award (NOA) for the Ryan White Treatment Extension Act Part A (Part A) Grant.

**BACKGROUND**

On March 2, 2021, the Commissioners Court, through Court Order #134895, approved the HRSA FY 2021-2022 NOA for the Part A Grant contract renewal for partial funding in the amount of \$1,079,630.00.

On April 13, 2021, the Commissioners Court, through Court Order #135199, approved Amendment No. 1 to the FY 2021-2022 HRSA NOA Part A to increase funding by \$3,760,377.00, bringing the total amount of funding to \$4,840,007.00.

On September 21, 2021, the Commissioners Court, through Court Order #136386, approved Amendment No. 2 to the FY 2021-2022 HRSA NOA for Part A to carryover FY 2021-2022 grant funding in the amount of \$55,879.00, bringing the total amount of funding to \$4,895,886.00.

On September 27, 2022, the Commissioners Court, through Court Order # 139241, approved Amendment No. 3 to the FY 2021-2022 HRSA NOA for Part A to de-obligate \$24,302.00, bringing the total amount of funding to \$4,871,584.00.

With approval of Amendment No. 4, \$561.11 will be de-obligated from FY2021-2022, bringing the total amount of funding to \$4,871,022.89.

The Part A Grant project period is March 1, 2021 through February 28, 2025. The Part A Grant budget period remains March 1, 2021 through February 28, 2022. All other terms and conditions not hereby amended remain in full force and effect.
