SUBJECT: APPROVAL OF AMENDMENT NO. 1 TO THE SUBRECIPIENT CONTRACT BETWEEN TARRANT COUNTY, D/B/A TARRANT COUNTY PUBLIC HEALTH AND CAN COMMUNITY HEALTH INC. FOR SERVICES RELATED TO THE TEXAS DEPARTMENT, OF STATE HEALTH SERVICES ENDING THE HIV EPIDEMIC GRANT

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 1 to the Subrecipient Contract between Tarrant County, d/b/a Tarrant County Public Health (TCPH) and CAN Community Health, Inc. (CAN) for services related to the Texas Department of State Health Services (DSHS) Ending the HIV Epidemic (EHE) Grant, Contract #HS000897700004.

BACKGROUND

On September 29, 2020, the Commissioners Court, through Court Order #133855, approved the FY 2021 DSHS EHE grant contract for grant funding in the amount of \$637,328.00 to advance HIV prevention and surveillance efforts. The term of the grant contract was August 1, 2020 through July 31, 2021.

On June 1, 2021, the Commissioners Court, through Court Order# 135579, approved Amendment No. 1 to the contract, adding funding in the amount of \$637,328.00 for FY 2022, decreasing funding by \$232,000.00 for FY 2021. In addition, the term of the contract was extended through July 31, 2023.

On September 21, 2021, the Commissioners Court, through Court Order #136406, approved the posting of a Request for Applications for EHE Sub-Awards.

On April 26, 2022, the Commissioners Court, through Court Order #137993, approved Amendment No. 2 to the contract, adding funding in the amount of \$637,328.00 for FY 2023.

On September 27, 2022, the Commissioners Court, through Court Order #139272, approved a Subrecipient Contract with CAN in the amount of \$40,000.00 for face-to-face HIV/STD prevention services and outreach contacts. The contract term is September 27, 2022 through July 31, 2023.

With approval of Amendment No. 1 to the Subrecipient Contract, funding for services will increase by \$10,000.00, bringing the new total contract amount to \$50,000.00. The budget and attachments are amended accordingly.

All other terms and conditions not hereby amended shall remain in full force and effect.
