It is requested that the Commissioners Court grant permission to take Bids/RFPs for the following:

a. RFP for In-Building Radio Coverage Enhancement for New Juvenile Courts Building

Estimated Value – \$76,954.00

Funding for this item was included in the FY 2023 Budget.

This contract is to provide radio infrastructure inside the Juvenile Courts Building to improve safety radio coverage. This contract is for the Sheriff's Office. The primary contact for this item is Daniel Webb, Information Technology.

b. RFB for Work Zone Traffic Lights

Estimated Value – \$67,000.00

Funding for this item is included in the FY 2024 Budget request.

This contract is for the purchase of mobile traffic lights for controlling traffic through work zones. This contract will be used by Precinct 4, Equipment Maintenance. The primary department contact for this item is Ned Pyle, Precinct 4 Maintenance.

c. RFP for Hazardous Mitigation Action Plan (HazMAP)

Estimated Value: \$100,000.00

Funding for this project will come from potential grant funding. The Grant application was approved on June 20, 2023, through Court Order #141096.

This contract is used to update the current HazMAP for Tarrant County as required by state and federal regulations. HazMAPs are used to assist communities within the County to identify hazards within their jurisdictions, as well as strategies to mitigate the impacts of these hazards. This contract will be used by the Emergency Management Department. The primary contact for this item is David McCurdy, Emergency Management.

d. 350 West Belknap Remodel of Floors 1-4

Estimated Value – \$22,188,468.00

Funding for this item was included in the FY 2023 Approved Budget as follows: \$8,000,000.00 through ARPA and the remaining \$14,188,468.00 will be funded through Capital funding.

This contract is for the renovation of floors 1-4 of the 350 West Belknap Building. The purpose of the project is to accommodate new office space for Justice of the Peace 5, Constable 5, Community Supervision and Correction (CSCD), Criminal Court Administration (CCA), and 2 Holding Cells for the Sheriff's Office. Floors 1 and 2 are funded using capital expenditure dollars and Floors 3 and 4 are funded using ARPA dollars. This project is managed by Facilities Management. The primary department contact for this item is Michael Amador, Director, Facilities Management.
